MINUTES OF ANTI RAGGING COMMITTEE AND SQUAD MEETING

A Meeting of the Anti Ragging Committee & Anti Ragging Squad was held on 28th February, 2023, 2.00 pm in the principal office. The meeting was chaired by Dr. Indrajeet Singhvi, Principal and all Anti Ragging Committee members were present. Dr. Indrajeet Singhvi congratulated the members of both the Committees for their efforts in preventing the Ragging incidents, both in the hostel as well as in the college campus for the previous year. He explained about the Rules & Regulations and consequences of Ragging as per AICTE & UGC. He also suggested the measures to be taken to curb the incidents of ragging.

The Members took an active part in the discussion and recommended the following measures to prevent ragging both in the Hostels and in the College Campus.

- 1. All the Wardens & Squad Members must visit the hostels daily.
- 2. To put posters and banners in the College, Hostels, Library, Co-Operative Store, Canteen & other prominent places mentioning the consequences of Ragging.
- 3. Senior staff members of the committee must supervise and take rounds in the Hostel and college premises specially after college hours and during night time. Also they are required to sign the registers kept for the purpose.
- 4. Anti Ragging squad members must make surprise visit to the Hostels and make signatures in the registers kept for the purpose.
- 5. Principal suggested that the Office bearers of the College Association as well as the student secretaries to take active part in preventing the Ragging.
- 6. Suggestion and complaint boxes are to be kept in all the Hostels.
- 7. Contact Phone numbers of Wardens and Anti Ragging Committee & Squad to be displayed in the Hostels, Library, Co-Operative Store & Canteen Notice Boards.
- 8. The Anti Ragging Committee must meet periodically after the admission of new students to college and hostels to review the arrangements made to prevent Ragging.
- 9. Security arrangements to be tightened during night time.

Before, proceeding the vote of thanks, the Chairman of the meeting once again requested all the members to work hard so that the freshers have a cordial atmosphere during their stay in this campus.

The meeting ended with vote of thanks to the Chair and other members.
