This means that there is a widespread culture of not speaking out on issues, one which affects the more socially and institutionally vulnerable students the most. Gender sensitization is not a matter for students alone but is required in all colleges and universities, and for all sections of the community - students, faculty in all disciplines, support staff and administration.

The Committee should find suitable solutions to settle the problems faced by the women staff / students in regard to matters relating to sexual harassment within 10 days' after thorough investigation. The Convener of the Committee should conduct meeting once in every three months and send minutes of the meeting to the undersigned.
